The rates published in this tariff will be according to one of the following services:

1. All Water: Port to Port or CFS to CFS
2. Alternate Port: Port to Port or CFS to CFS plus any alternate port arbitrary
3. Specific Point: Point to Port/CFS, Port to Point/CFS or Point to Point rates as contained in applicable rates

For the purposes of Rate & Ruling filings, the following designations shall be reflected herein:

Caribbean Base Ports shall mean: Anguilla, Antigua, Aruba, Barbados, BVI, Cuba, Curacao, Grand Cayman, Grenada, Guyana, Haiti, Jamaica, Montserrat, St Kitts, St Lucia, St Maarten, St Vincent, Suriname, Tortola, Trinidad and USVI.

Dominican Republic & Central America Base Ports shall mean: Dominican Republic, Costa Rica, El Salvador, Guatemala, Honduras, Nicaragua and Panama.
